The Closing of our Businesses are in the Hands of our local City & / or County Officials


At this time here is a list of areas in Texas (that I know of) that have ordered the closing of Beauty related business

If you're still open, we recommend using a scheduling appointment booking system that allows ample time for you to complete the booked service before the next client arrives.

Allow a 10 minute sanitation break between customers.

Practice Social Distancing in Common Areas
Shampoo Waiting

Wipe Down or spray Styling & waiting area Chairs with disinfectants after each client.

Use neck strips or clean towels on each client

If you have an UV or other type of other electronic sanitizer be sure to use it


Replace barbercide / disinfectant solution

regularly

Place a Roll of Paper Towel inside & outside your door for client to use when opening

Disinfect Doors and Hard surfaces frequently
